

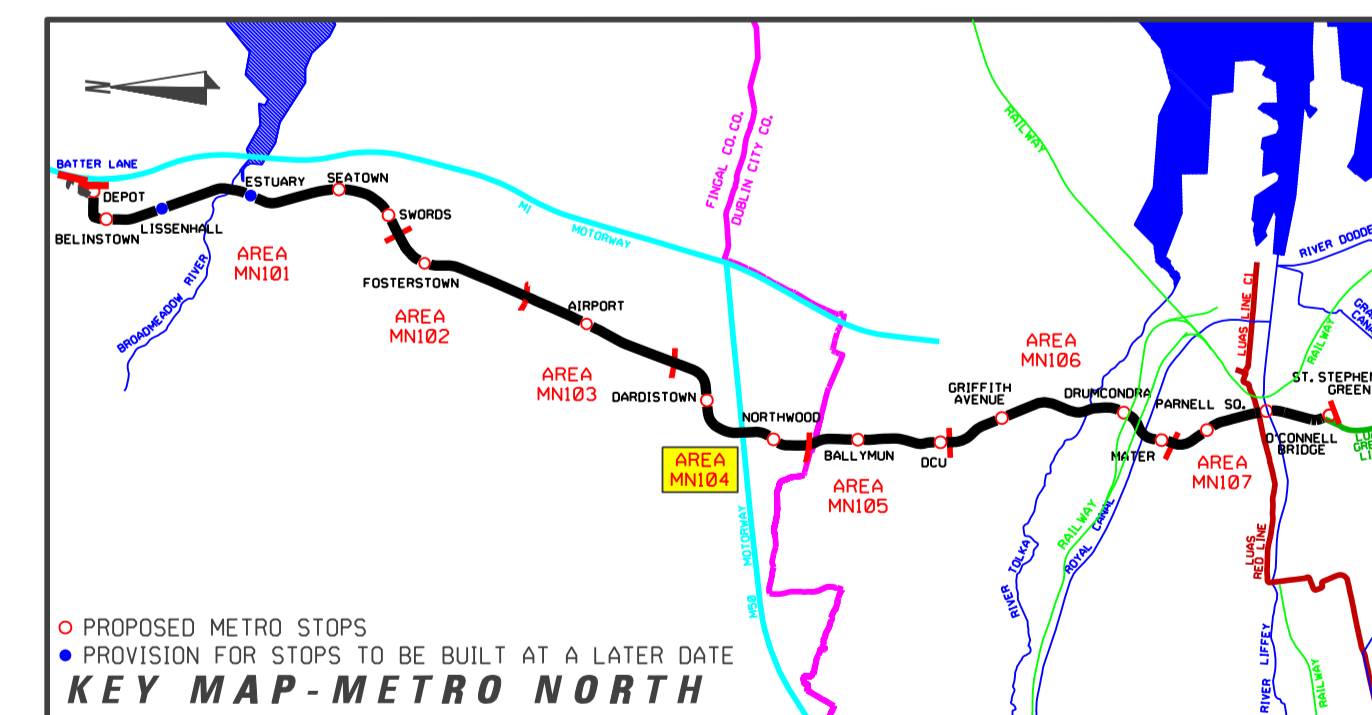
LOCATION PLAN
