#### General

Transport Infrastructure Ireland (TII) was set up to deliver and operate safe and efficient light rail and national road networks. TII's mission is to deliver transport infrastructure and services that contribute to the quality of life of the people of Ireland and support the country's economic growth.

TII's ability to deliver and operate light rail and roads networks efficiently is recognised, as evidenced by the portfolio of National Development Plan (NDP) 2021–2030 investments entrusted to TII and its partners to deliver.

Under the NDP there are three areas under the remit of TII which identify key priorities:

1) Investment in public transport infrastructure to be delivered on behalf of the National Transport Authority (NTA) in line with the Transport Strategy for the Greater Dublin Area 2022-2042. This Strategy commits to the undertaking of appraisal, planning and design of Luas network expansion to Bray, Finglas, Lucan and Poolbeg. Importantly, the Plan also sets out a firm commitment to deliver a metro rail system known as MetroLink that will run from Swords to Charlemont, connecting Dublin

Airport with the city centre and providing interchanges with other public transport services including larnrod Eireann at Glasnevin, the DART at Tara Street and Luas at O'Connell Street and Charlemont. TII also delivers light railway infrastructure being planned in other cities. Currently TII is working in partnership with the NTA on the planning and design of Cork Light Rail Transit, which is expected to operate initially as a bus rapid transit system.

- 2) Investment in national roads, active travel and Greenway infrastructure will be delivered in accordance with the guiding principles of the Department of Transport, National Investment Framework for Transport in Ireland and the Strategy for Future Development of National and Regional Greenways. The major roads, active travel and Greenways projects to be delivered and funding provisions are set out in the NDP 2021 to 2030. TII also has a new function for the delivery of zero and low emission vehicle infrastructure (ZEVI) under the Road Traffic and Roads Act 2023.
- 3) Investment in maintenance and renewal expenditure will need to increase over the lifetime of the NDP to meet the required investment levels for the current transport network and for new projects as they come into service.

TII's ambitious plans for infrastructural delivery will drive Ireland's long term economic, environmental and social progress across all parts of the country over the next decade. The NDP, which is aligned with the delivery of the objectives of the National Planning Framework (NPF), sets out a roadmap and the level of investment which will underpin the NPF and drive its implementation over the next ten years.

#### **BACKGROUND**

The Strategic and Transport Planning section in TII carries out strategic studies and assesses current and future national road, light rail and active travel infrastructure needs. This includes monitoring the performance of current networks and understanding the potential usage and benefits of proposed infrastructure improvements. The Section identifies how existing infrastructure can be optimised and where network upgrades are necessary. It maintains the National Transport Model for national roads, supports project colleagues developing public transport demand models and manages acquisition and/or development of active travel demand modelling tools. The section conducts surveys, collects data and undertakes strategic studies relating to all transport systems in which TII has an interest.

The Section ensures compliance with relevant national policies and guidelines related to the appraisal of transport projects and programmes. It updates Project Appraisal Guidelines for active travel and national road projects and carries out audits on Business Cases for capital projects and operational programmes in line with Infrastructure Guidelines from the Department of Public Expenditure NDP Delivery and Reform, and the Department of Transport's Transport Appraisal Framework. The work of the Section is supported by Transport Planning technical advisers.

The Section keeps abreast of emerging developments which have the potential to impact on TII's business, e.g. strong policy support for and prioritisation of active travel, new mobility services and efforts to decarbonise transport systems. It leads the development of TII's strategies in response to these new trends.

The section is conscious of the potential transport, environmental, health and low-impact tourism benefits that may arise following the provision of greenways, cycling networks and larger scale rural active travel infrastructure projects. The section embraces the challenge of integrating the environmental, social and economic pillars of sustainability into the planning and appraisal of such projects.

#### **Role Overview:**

As part of the ongoing investment in existing national transport networks and delivery of a nationwide programme of capital investment projects, applications are invited for the position of Graduate Economist within the Strategic and Transport Planning Department of Transport Infrastructure Ireland. The post holder will report to the Head of Strategic and Transport Planning. This role will involve mentorship and hands on opportunities to build expertise in strategic and transport planning through actively participating in a variety of projects and initiatives.

# **Training & Support**

The graduate will be enrolled on a formal training course to support the development of their professional skills. Technical training will also be provided.

Graduate will be provided with a mentor and buddy in addition to their Line Manager.

#### **ROLE, DUTIES AND RESPONSIBILITIES**

- Assist in ensuring the department meets its annual business plan objectives.
- Support the technical review of materials delivered by transport planning and economic advisers.
- Develop processes and techniques for data analysis and appraisal of transport projects
- Analyse data to identify economic trends in demand for transport services and profile transport system users and their decision making
- Develop material to communicate and disseminate findings, both internally and through external channels.
- Collaborate with team members, other divisions, and external stakeholders.
- Present information clearly and effectively.
- Maintain professional relationships and network with other relevant organisations
- Assist the Head of Strategic and Transport Planning in fulfilling annual business plan objectives.
- Contribute to the development of economic appraisal guidelines to be applied to TII projects
- Analyse data to identify economic aspects of trends in usage of TII transport systems
- Collaborate with team members, other divisions, and external stakeholders.

- Present and report information clearly and effectively.
- Develop professional relationships across TII and partner stakeholders

All the divisions within TII have inter-dependant responsibilities and close cooperation, collaboration and teamwork are required across the whole organisation to meet tight deadlines.

**Note:** The functions and responsibilities assigned to this position are based on the current stated role and may be changed from time to time. The person appointed will be required to demonstrate the flexibility necessary to fulfil other roles and responsibilities at a similar grade within TII.

#### **ESSENTIAL REQUIREMENTS**

#### Character

Each candidate must be of good character.

#### Health

A candidate for and any person holding the role must be fully competent and capable of undertaking duties attached to the role and be in a state of health such as would indicate a reasonable prospect of ability to render regular and efficient service.

## **Education & Experience**

The successful candidate will be required to demonstrate the key competencies for a Grade 3 position, as well as the following experience and job-specific requirements:

- A Degree or third-level professional qualification (NFQ Level 8 or equivalent) in economics, transport, social geography, sustainability, statistics, mathematics, business or similar.
  - If you are a final year student who has recently completed exams you will be eligible to apply, however you will be required to provide proof of having achieved your qualification before any offer of employment can be made.
- Experience in research, data analysis, or report writing.
- General understanding of economics relevant to capital investment
- Highly numerate with strong analytical skills.
- Ability to multitask across multiple projects.
- Strong communication skills, both verbal and written.
- Effective team player with the ability to establish and maintain professional relationships.
- Fluency in English, both written and oral.

# **Desirable Requirements**

- Interest in the transport sector
- Interest in transport or economic modelling.
- Experience in preparing presentations and reports.
- Knowledge of statistical analytical tools

#### Note:

In order to assure the shortlisting panel that you satisfy these requirements you must explicitly reference how you meet the requirements in your application. Failure to demonstrate these may prevent your application progressing to future shortlisting stages.

Candidates who come under consideration following the final selection stage will be required to provide documentary evidence of their eligibility, including qualifications and evidence of fluency in the English language.

Candidates who are unable to show that they hold the required qualifications may be withdrawn from the competition at any stage. An invitation to interview or any element of the selection process is not acceptance of eligibility.

## **PRINCIPAL CONDITIONS OF SERVICE**

## Pay

The scale of pay for Grade 3 as of 1 March 2025 is as follows:

# Personal Pension Contribution (PPC) Pay Scale:

€39,083 - €78,830 - personal pension contribution (PPC) rate. This salary is payable to an individual who is required to make a personal pension contribution (PPC) to their main pension (in general those persons whose initial appointment to the Public Service is on or after 6th April 1995).

## Non PPC Scale:

**€40,803** - **€75,00** - non personal pension contribution (non-PPC) rate. This salary is payable to an individual who is not required to make a personal pension contribution (PPC) to their main pension scheme.

#### Note

- Entry salary will be at the minimum point of the scale and will not be subject to negotiation
- Different pay and conditions may apply if, immediately prior to appointment, the appointee is already a serving Civil Servant or Public Servant
- The rate of remuneration may be adjusted from time to time in line with Government pay policy.

#### Tenure

Full time, permanent position subject to satisfactory completion of probation period.

#### **Annual Leave**

The appointee will be entitled to 25 days annual leave, rising to 29 after 5 years' service and to 30 after 10 years of service. This leave is exclusive of public holidays.

#### **Superannuation and Retirement**

The successful candidate will be offered the appropriate superannuation terms and conditions as prevailing in the Civil Service at the time of being offered an appointment. In general, an appointee who has never worked in the Public Service will be offered appointment based on membership of the Single Public Service Pension Scheme ("Single Scheme"). Full details of the Scheme are at <a href="https://www.singlepensionscheme.gov.ie">www.singlepensionscheme.gov.ie</a>

Where the appointee has worked in a pensionable (non-Single Scheme terms) public service job in the 26 weeks prior to appointment or is currently on a career break or special leave with/without pay different terms may apply. The pension entitlement of such appointees will be established in the context of their public service employment history.

Key provisions attaching to membership of the Single Scheme are as follows:

- Pensionable Age: The minimum age at which pension is payable is 66
- Retirement Age: Scheme members must retire on reaching the age of 70.
- Career average earnings are used to calculate benefits (a pension and lump sum amount accrue each year and are up-rated each year by reference to CPI).
- Post retirement pension increases are linked to CPI.

#### **Pension Abatement**

If the appointee has previously been employed in the Civil or Public Service and is in receipt of a pension from the Civil or Public Service or where a Civil/Public Service pension comes into payment during his/her re-employment that pension <u>will be subject to abatement</u> in accordance with the Public Service Pensions (Single Scheme and Other Provisions) Act 2012, (the 2012 Act). <u>Please note: In applying for this position you are acknowledging that you understand that the abatement provisions, where relevant, will apply. It is not envisaged that the employing Department/Office will support an application for an abatement waiver in respect of appointments to this position.</u>

However, if the appointee was previously employed in the Civil or Public Service and awarded a pension under voluntary early retirement arrangements (other than the Incentivised Scheme of Early Retirement (ISER), the Department of Health Circular7/2010 VER/VRS or the Department of Environment, Community & Local Government Circular letter LG(P) 06/2013 which, renders a person ineligible for the competition) the entitlement to that

pension will cease with effect from the date of reappointment. Special arrangements may, however, be made for the reckoning of previous service given by the appointee for the purpose of any future superannuation award for which the appointee may be eligible.

# Department of Education and Skills Early Retirement Scheme for Teachers Circular 102/2007

The Department of Education and Skills introduced an Early Retirement Scheme for Teachers. It is a condition of the Early Retirement Scheme that with the exception of the situations set out in paragraphs 10.2 and 10.3 of the relevant circular documentation, and with those exceptions only, if a teacher accepts early retirement under Strands 1, 2 or 3 of this scheme and is subsequently employed in any capacity in any area of the public sector, payment of pension to that person under the scheme will immediately cease. Pension payments will, however, be resumed on the ceasing of such employment or on the person's 60<sup>th</sup> birthday, whichever is the later, but on resumption, the pension will be based on the person's actual reckonable service as a teacher (i.e. the added years previously granted will not be taken into account in the calculation of the pension payment).

#### **Ill-Health Retirement**

Please note that where an individual has retired from a Civil/Public Service body on the grounds of ill-health his/her pension from that employment may be subject to review in accordance with the rules of ill-health retirement within the pension scheme of that employment.

## **Pension Accrual**

A 40-year limit on total service that can be counted towards pension where a person has been a member of more than one pre-existing public service pension scheme (i.e. non-Single Scheme) as per the 2012 Act shall apply. This 40-year limit is provided for in the Public Service Pensions (Single Scheme and other Provisions) Act 2012. This may have implications for any appointee who has acquired pension rights in a previous public service employment.

#### **Additional Superannuation Contribution**

This appointment is subject to the Additional Superannuation Contribution (ASC) in accordance with the Public Service Pay and Pensions Act 2017.

#### **Eligibility and Certain Restrictions on Eligibility to Compete**

Candidates should note that eligibility to compete is conditional upon candidates, where applicable, having the necessary requisite work permits/visas/permissions to enable them to work legally in this country.

#### Appointments from panels

It is envisaged that a panel of qualified individuals will be established from which vacancies for this position may be filled within 12 months from date of appointment to panel. Qualification and placement on a panel is **not** a guarantee of appointment to a position.

Please note that once an offer of appointment has been accepted a candidate will be removed from the panel and no further offers of appointment will be made.

# **Incentivised Scheme for Early Retirement (ISER)**

It is a condition of the Incentivised Scheme for Early Retirement (ISER) as set out in Department of Finance Circular 12/09 that retirees, under that Scheme, are debarred from applying for another position in the same employment or the same sector. Therefore, such retirees may not apply for this position.

# **Department of Health and Children Circular (7/2010)**

The Department of Health Circular 7/2010 dated 1 November 2010 introduced a Targeted Voluntary Early Retirement (VER) Scheme and Voluntary Redundancy Scheme (VRS). It is a condition of the VER Scheme that persons availing of the scheme will not be eligible for reemployment in the public health sector or in the wider public service or in a body wholly or mainly funded from public monies. The same prohibition on re-employment applies under the VRS, except that the prohibition is for a period of 7 years, after which time any reemployment will require the approval of the Minister for Public Expenditure and Reform. People who availed of either of the schemes or other Public Sector Voluntary Redundancy Schemes are not eligible to compete in this competition.

# Department of Environment, Community & Local Government (Circular Letter LG (P) 06/2013)

The Department of Environment, Community & Local Government Circular Letter LG (P) 06/2013 introduced a Voluntary Redundancy Scheme for Local Authorities. In accordance with the terms of the *Collective Agreement: Redundancy Payments to Public Servants* dated 28 June 2012 as detailed above, it is a specific condition of that VER Scheme that persons will <u>not</u> be eligible for re-employment in any Public Service body [as defined by the Financial Emergency Measures in the Public Interest Acts 2009 – 2011 and the Public Service Pensions (Single Scheme and Other Provisions) Act 2012] for a period of 2 years from their date of departure under this Scheme. Thereafter, the consent of the Minister for Public Expenditure and Reform will be required prior to re-employment. These conditions also apply in the case of engagement/employment on a contract for service basis (either as a contractor or as an employee of a contractor).

# **Collective Agreement: Redundancy Payments to Public Servants**

The Department of Public Expenditure and Reform letter dated  $28^{th}$  June 2012 to Personnel Officers introduced, with effect from  $1^{st}$  June 2012, a Collective Agreement which had been reached between the Department of Public Expenditure and Reform and the Public Services Committee of the ICTU in relation to ex-gratia Redundancy Payments to Public Servants. It is a condition of the Collective Agreement that persons availing of the agreement will not be eligible for re-employment in the public service by any public service body (as defined by the Financial Emergency Measures in the Public Interest Acts 2009 - 2011) for a period of 2 years from termination of the employment.

People who availed of this scheme and who may be successful in this competition will have to prove their eligibility (expiry of period of non-eligibility).

#### Declaration

Applicants will be required to declare whether they have previously availed of a public service scheme of incentivised early retirement. Applicants will also be required to declare any entitlements to a Public Service pension benefit (in payment or preserved) from any other Public Service employment and/or where they have received a payment-in-lieu in respect of service in any Public Service employment.

The above represents the principal conditions of service and is not intended to be the comprehensive list of all terms and conditions of employment which will be set out in the employment contract to be agreed with the successful candidate.

#### **Selection Methods**

TII will convene an expert board to carry out the competitive stages of the selection process to the highest standards of best practice. The approach employed may include:

- Shortlisting of candidates on the basis of the information contained in their application;
- A competitive, competency focused, interview using Microsoft Teams;
- A second round interview
- Presentation/Work sample/role play/media exercise, and any other tests or exercises that may be deemed appropriate; and
- Reference and online checks.

#### Shortlisting

Normally the number of applications received for a position exceeds that required to fill the position. While you may meet the eligibility requirements of the competition, if the numbers applying for the position are such that it would not be practical to interview everyone, TII may decide that a smaller number only will be called to interview. In this respect, TII provides for the employment of a shortlisting process to select a group for interview who, based on an examination of the documents provided by you, appears to be the most suitable for the position.

This is not to suggest that other candidates are necessarily unsuitable, or incapable of undertaking the job, rather that there are some candidates who are, prima facie, better qualified and/or have more relevant experience.

During any shortlisting exercise that may be employed, TII is guided by an interview board who examines the applications and assesses them against pre-determined criteria based on the

# **Purpose of Processing**

TII conducts a competency based recruitment process to fill vacancies within the organisation.
